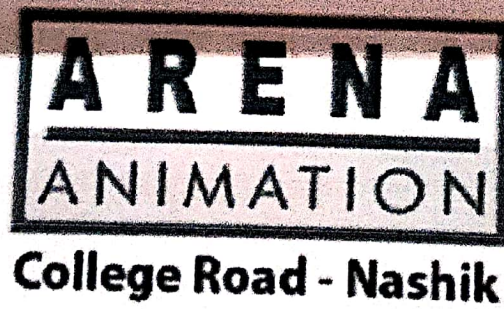

**Responsibility and Important Terms of ARENA Animation:**


- Arena Animation authorities shall visit your college on a basis of 4 times in a year, and shall conduct seminars.


